Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Chamal Jayantha Rajapaksha, Minister of Agriculture Development hereby declare, under Sub-section (1) of Section 5 of the land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land depicted as Lot 'A' and 'B' in Advance Tracing No. KA/BRW/05/518 and dated 20.10.2005 made by Surveyor-General of the land called Thuppahiyawatta *alias* Kaluwediyawatta situated at the village of Angangoda in Divisional Secretariat Division of Beruwala in the District of Kalutara, and containing in extent about 0.1338 Hectare and bounded as follows;

01. Lot 'A' – Thuppahiyawatta *alias* Kaluwediyawatta – Extent: 0.0713 Hectare

North: Pelawatta (claimant is not known) and Pahalawatta claimed by L. A. Saluwadana; East: Pahalawatta claimed by L. A. Saluwadana and Thuppahiyawatta *alias* Kaluwediyawatta claimed by Weerakoon

Siripala and others; South: Thuppahiyawatta *alias* Kaluwediyawatta claimed by Weerakoon Siripala and others and road; West: Road and Pelawatta (claimant is not known).

02. Lot 'B' – Thuppahiyawatta *alias* Kaluwediyawatta – Extent: 0.0625 Hectare

North: Pelawatta (claimant is not known) and road; East: Road and Thuppahiyawatta *alias* Kaluwediyawatta claimed by Weerakoon Siripala; South: Thuppahiyawatta *alias* Kaluwediyawatta claimed by Weerakoon, Siripala and Mohottiyawatta claimed by Donaman Jayathunga; West: Mohottiyawatta claimed by Donaman Jayathunga and Pelawatta (claimant is not known).
