Notice under Section 7

I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for construction of the Storage Tank of North Division, Water Filter, OIC's Quarters and the Care Takers Quarters of Anuradhapura Group Town Water Supply Project .

Description of the land to be acquired :

Six allotments of land called Horanakele *alias* Rasheediah Watta in total extent of about 0.8236 Hectare depicted as Lot Nos. 2260, 2261, 2262, 2263, 2264, 2265 of Town Survey Preliminary Plan No. 14B, Sheet No. 88 and Supplement 81 of 07.03.2006 prepared by the Surveyor - General, Situated in Anuradhapura City ward No. 3, Jaffna Junction within the Municipal Limits of Anuradhapura Municipal Council in the Divisional Secretary's Division of Nuwaragampalatha East in Anuradhapura District, and bounded as follows:
