THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Chamal Jayantha Rajapaksha, Minister of Agriculture Development, do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

An allotment of land depicted as Lot A in Advance Tracing No. H/AMB/2004/497 dated 2004.10.03 made by the District Superintendent of Surveys Hambantota and situated in the village of Punchihenayagama in the Magampattuwa Minor Division in the Divisional Secretary's Division of Ambalantota, Hambantota District containing in total extent of 0.004 Hectare and bounded as follows:

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Chamal Jayantha Rajapaksha, Minister of Agriculture Development, here by declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act:

An allotment of land called field No. 5 and 6 of Kosgulanahena or Ensalwatta State, extents and boundaries of which are given below, situated at the village of Mathugobe at Minor Division of Morawak Korale of Divisional Secretariat, Kotapola in the District of Matara in Southern Province, depicted as Lot 'A' in Surveyor-General's Advance Tracing No. MR/KTP/2002/620 dated 29.08.2002 and containing totally in extent about 5.374 Hectares.

Lot No. A – Kosgulanahena or Ensalwatta-Field No. 5 and 6 – Extent: 5.374 Hectare

North: A part of this land, Viharahena-Singharaja Road and a part of the land; East: A part of this land; South: Ela; West: Ela, a part of this land and access road from Viharahena to Sinharaja.
