INDUSTRIAL DISPUTES ACT (CHAPTER 131)

Schedule

BY virtue of the powers vested in me under Section 22 of the Industrial Disputes Act, Chapter 131, Legislative Enactments, Ceylon (Revised Edition 1956) as amended by the Industrial Disputes (Amendments) Act, Nos. 14 and 62 of 1957 and 4 of 1962 (read with Industrial Disputes (Special Provisions) Act, No. 39 of 1968), I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka do hereby—

- (1) Appoint the persons specified in the Schedule hereto be members of the panel of which Industrial Courts shall be constituted ; and
- (2) Specify the period of three years from 01st November, 2006 as the period of office of such members.
