I, Chamal Jayantha Rajapaksa, Minister of Agriculture Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Lot A,B,C,D, E,F,G,H and I (09) allotments of land in total extent of about 0.568 Hectare depicted in Advance Tracing No. MT/HKM/2005/272 dated 16.07.2005 prepared by the Surveyor-General situated in the Village of Lalpe in the Divisional Secretary's Division of Hakmana in Matara District and bounded as follows:
