##### Finance Statute No. 06 of 1990

##### ORDER UNDER SECTION 7

BY virtue of the powers vested in me under Section 7 (1) of the Finance Statute No. 06 of 1990 of the Sabaragamuwa Province Provincial Council, I, Maheepala Herath, Chief Minister and Minister of Finance, Planning, Law and Order, Education and Information Technology, Transport, Media, Cultural Affairs and Estate Welfare of the Sabaragamuwa Province Provincial Council, do by this order, fix the following rates of Turnover Tax which shall come into effect from the midnight of 31st October, 2006/01st November, 2006 : –

| (b) In respect of the turnover of business of buying and selling precious or semi precious stones   | 05% |

| (d) In respect of the turnover of business of buying and selling furniture (including steel furniture)  | 05% |
| (e) In respect of the turnover of business of buying and selling jewellery and costume jewellery  | 05% |
| (f) In respect of the turnover of business of buying and selling Arrack (including processed Arrack and Blends of Arrack), Beer, Wine, Toddy and other varieties of imported or locally manufactured Liquor | 02% |
| (g) In respect of the turnover of business of selling Cigarettes purchased from the manufacture of such cigarettes or from the importer of such cigarettes  | 02% |
| (h) In respect of the turnover of business of buying and selling any article or commodity other than any business referred to under items (a), (b), (c), (d), (e), (f) and (g) above                        | 01% |

02. The order published in the *Gazette Extraordinary* No. 1132/2 dated 15th May, 2000 of the Democratic Socialist Republic of Sri Lanka and amendments thereto shall cease to apply, upon the coming into effect of this order, in respect of any turnover arising after the midnight of 31st October, 2006/01st November, 2006.
