BY virtue of the powers vested in me under Section 7(1) of the Finance Statute No. 08 of 1990 of the North Western Province Provincial Council, I, Wijesinghe Hettiachchi Mudiyanseelage Athula Sarath Kumara Wijesinghe, Chief Minister and Minister in-Charge of the subject of Finance of the North Western Province Provincial Council, do by this order fix the following rates of Turnover Tax which shall come into effect from the midnight of 31st October, 2006/01st November, 2006.

manufactured Liquor | 02% |
| (g) In respect of the turnover of business of selling Cigarettes Purchased from the
manufacture of such Cigarettes or from the importer of such Cigarettes | 02% |
| (h) In respect of the turnover of business of buying and selling any article or commodity other
than any business referred to under items (a), (b), (c), (d), (e), (f) and (g) above | 01% |

2. The order made under this Section and published in the *Gazette* No. 643 of 28th December, 1990 of the Democratic Socialist Republic of Sri Lanka and amendments thereto shall cease to apply, upon the coming into effect of this order, in respect of any turnover arising after the midnight of 31st October, 2006/01st November, 2006.
