##### Column I

Bisowala mentioned in sixth line shall be change as Bisowela, Dematanpitiya mentioned in same line shall be changed as Dembatanpitiya, it shall be include Part of Grama Niladhari Divisions after the words and in sixth line. Aasideniya mentioned in seventh line shall be change as Asideniya, it shall be include No. 70B Yattogoda following the Palapoluwa mentioned in seventh line.

##### Column II

*North* : Yottagoda mentioned in first line shall be replaced with Yattogoda, Northeastwards along the said foot path until it meets the western boundary of Porambe Grame Niladahri Division mentioned in fifth and sixth lines shall be replaced with northeastwards until it meets the point at a distance of 200 meters from the meeting point of northern boundary of Yattogoda Grama Nildhari Division and the Western boundary of Peherambe Grama Niladhari Divison.

*East* : In No. 3/74 mentiioned in third lline shall be changed as 74/3.

*South* : Dematampitiya mentioned in fifth line shall be change as Dembatanpitiya. Instead of seventh, eighth, ninth and tenth lines those shall be replaced with until it meets the northern boundary of Aassideniya village thence southwestwards along the northern boundary of said village until it meet the northern boundary of Warakapola Divisional Secretary Division.

*West* : No. 1/69 mentioned in fourth line shall be changed as No. 69/1 and Dimbiyagastenna Road mentioned in ninth and twelfth line shall be change as Dimbiyangastenna Estate Road.
