THE LAND ACQUISITION ACT, (CHAPTER 460)

Order under Section 49 A

BY virtue of the powers vested in me by Section 49 A of the Land Acquisition Act, (Chapter 460), read with Article 44 of the Constitution, I, Dr. Sarath Amunugama, Minister of Enterprise Development and Investment Promotion of the Democratic Socialist Republic of Sri Lanka, do by this Order, declare that the land specified in the Schedule hereto is required for the purpose of the Board of Investment of Sri Lanka being a public corporation established by the Board of Investment of Sri Lanka Law, No. 4 of 1978.
