THE REVENUE PROTECTION ACT, No. 19 OF 1962

**ORDER**

BY virtue of the powers vested in me under Section 2 of the Revenue Protection Act, No. 19 of 1962, read with Article 44 (2) of the Constitution of the Democratic Socialist Republic of Sri Lanka, I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka, do by this Order from 03rd February, 2007, require the Director General of Customs to demand and levy on each article specified in Column 3 of the Schedule hereto, import duty at the general rate set out in the corresponding entry in Column 5 of that Schedule or where a preferential rate is leviable and payable under the Provisions of Schedule “A” of the Customs Ordinance (Chapter 235), at the preferential rate set out in the corresponding entry in Column 4 of that Schedule.
