THE NATIONAL WATER SUPPLY AND DRAINAGE BOARD ACT, No. 02 OF 1974

Order under Section 64(1)

BY virtue of the powers vested in me under Section 64(1) of the National Water Supply and Drainage Board Act, No. 02 of 1974, I, Dinesh Gunawardana, the Minister of Urban Development and Water Supply, do by this order, embody in the schedule hereto the provisions of the voluntary transfer scheme approved by me under Section 63(1) of the aforesaid Law, in respect of the water supply undertakings carried on by the Haputale Urban Council.

SCHEDULE

Contents of the voluntary Transfer Scheme Section 61(1) :

- (a) The following movables and immovable property to be transferred to and vested in the National Water Supply and drainage Board to, wit :
 - (i) All lands, structures, water mains and installations of all the mechanical, electrical plant and machinery necessary to operate and maintain the service reservoirs, pumping stations, office premises together with all spares, stand by equipment and stores necessary such plant for the Haputale Water Supply Scheme listed in schedule 1.
 - (ii) All trunks and distribution mains together with servitude for water mains, spares, standby equipment and stores necessary to operate and maintain the water supply scheme situated within the limits of the Haputale Urban Council Authority area.

- (b) The rights, obligations and liabilities of the Haputale Urban Council together with any contract the Council has entered into in connection with design, supply, installation, construction, operation and maintenance with respect of the aforesaid property will also be transferred to the Board.
- (c) All agreements entered into with water consumers with regard to conditions of the use and supply of water services and payments to obtain such services will also be transferred to the Board.
- (d) The assets of these facilities valued at Rs. 14,705,400.00 (Sri Lanka Rupees Fourteen Million Seven Hundred and Five Thousand and Four Hundred) will be provided on a grant to the Board by the Government.
- (e) All agreements entered into by the Haputale Urban Council in connections with water supply will also be continued and honoured by the Board. The above transfer will come into effect from the date of publication of this notice.
