TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)

Order under Sections 6 (2) (b) and Section 21 (2) (b)

BY virtue of the powers vested in me by Section 6 (2) (b) and Section 21 (2) (b) of the Town and Country Planning Ordinance (Chapter 269), I, Dinesh Chandra Rupasinghe Gunawardena, Minister of Urban Development and Sacred Area Development, do by this Order :-

- (a) declare that the area of land specified in the Schedule hereto shall be an Urban Development area for the purpose of the aforesaid Ordinance and shall be called the “Bellanwila Raja Maha Vihara Sacred Area” ; and
- (b) direct that an outline scheme shall be prepared for the whole of the area declared to be the Bellanwila Raja Maha Vihara Sacred Area.

SCHEDULE

THE AREA OF LAND COMPRISING THE BELLANWILA RAJA MAHA VIHARA SACRED AREA
