THE PUBLIC SECURITY ORDINANCE (CHAPTER 40)

REGULATIONS made by the President under Section 5 of the Public Security Ordinance (Chapter 40).

Regulations

1. These regulations may be cited as the Emergency (Restriction on the Procurement of certain Items) Regulations No. 5 of 2007.

2. From and after the coming into force of these regulations, no person who being a Sri Lanka National, whether resident within or outside Sri Lanka shall, procure, or cause to be procured, aid or abet the procurement of, or provide financial assistance for the procurement of, military equipment, which equipment amounts to prohibited Items. A list of prohibited items is contained in the Schedule to these regulations.

Provided however, the Secretary to the Ministry of the Minister in charge of the subject of Defence, may, in exceptional circumstances enlarge the list contained in the Schedule hereto if it appears to him that it is necessary so to do in the interest of national security, the preservation of public order and the maintenance of supplies and services essential for the life of the community.

Provided further, the Secretary to the Ministry of the Minister in charge of the subject of Defence may in exceptional circumstances in the interest of national security, prohibited items which in his opinion are similar to, or resemble very closely, in its appearance, operation or effect, any of the items specified in this Schedule to these regulations.

3. Any person who contravenes the provisions of these regulations shall be guilty of an offence. Any person who has committed an offence under these regulations shall on conviction after trial by the High Court of Sri Lanka holden in Colombo or the High Court established under Article 154P of the Constitution for the Western Province, holden in Colombo, be liable to rigorous imprisonment for a term not less than three months and not exceeding five years and to a fine of not less than five hundred thousand rupees.
