REVOCATION OF ORDER UNDER SECTION 2 OF THE URBAN DEVELOPMENT PROJECTS  
(SPECIAL PROVISIONS) ACT, No. 2 OF 1980

BY virtue of the powers vested in me under Section 2 of the Urban Development Projects (Special Provisions) Act, No. 2 of 1980. I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka upon the recommendation of the Minister-in-charge of the subject of Urban Development Proclaimed under *Extraordinary Gazette* No. 1455/15 dated 25.07.2006 that the lands specified in the Schedule were urgently required for the purpose of carrying an Urban Development Project. Since the above mentioned lands are no longer required for the above mentioned Project, I do hereby cancel the *Gazette* Notification No. 1455/15 dated 25.07.2006 published under the *Extraordinary Gazette*.
