I, Jeewan Kumaranathunga, Minister of Land and Land Development hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Land described below is needed for a public purpose and will be acquired under the provisions of that Act:
