THE LAND ACQUISITION ACT (CHAPTER 460)

Notice Under Section 7

Reference No.: Bagama /DS//2/2/17.

I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired

(1) An allotment of land in total extent of 0.578 Hectare, as Lot No. 1, depicted in Preliminary Plan No. Ga 3531 and dated 20.08.2007, prepared by the Surveyor-General situated in Pahala Keebiya Village in the Baddegama Divisional Secretary's Division in the District of Galle in Southern Province morefully described as follows:

1. Lot No. 1

Name of land: Sytrus Watta; Description: Garden 04 permanent building and there is Mixed cultivation; Claimant: State; Original Claimant: Chairman, Land Reform Commission; Extent: 0.578 Hectare.
