THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Three (03) allotments of land called Madahapolaya Kumbura containing about 0.0348 Hectare in extent marked as Lots 'A', 'B' and 'C', depicted in Advance Tracing No. KU/IBB/2006/427 and dated on 16th November, 2007, prepared by Survey-General and situated in the village of Daramitipola (1228 FVP) in Minor Division of Hetahaye Korale in Divisional Secretary's Division of Ibbagamuwa in the District of Kurunegala in North Western Province.

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

The land depicted as Lot 01 – 05 in Advance Tracing No. Nu/KTM/2006/208 and dated 2007.01.31, prepared by the Surveyor-General and total extent of about 0.7074 Hectare, situated at

Niyangandora Village in Minor Division Udapane Koralaya in the Divisional Secretary's Division, Kotmale in the District of Nuwara- Eliya in Central Province, and bounded as follows:

1. Lot 'A' - Paluwatta - Extent: 0.2834 Hectares
