## THE WAGES BOARDS ORDINANCE

### Beedi Manufacturing Trade

IT is hereby notified under Section 29(3) of the Wages Boards Ordinance (Chapter 136), that the decisions of the Wages Board for the Beedi Manufacturing Trade made under Section 30 of that Ordinance and specified in the Schedule hereto have been approved by the Hon. Minister of Labour Relations and Manpower.

The decisions shall come into force on the 1st day of May, 2008.

### SCHEDULE

The decisions made by the Wages Board for the Beedi Manufacturing Trade and set out in the Schedule to the notification published in the Gazette Extraordinary No. 11208 of November 29, 1957, as varied from time to time and last varied by Notification in the Gazette Extraordinary No. 1207/28 of October 26, 2001, shall be further varied, by the substitution, for part 11 of that Schedule, of the following new part.

### PART II

#### THE MINIMUM RATES OF WAGES FOR PIECE WORK

The minimum rates of wages for piece work for Beedi Rolling (inclusive of the preparation of wrappers for rolling, cutting, wrapping leaves, filling wrappers with "Beedi Tobacco", Beedi Rolling and tying rolled Beedies) shall be:-

|--|---|----------------------------------|
| (a) for Beedies not more than 2 inches long                    | - | Rs. 162.00 per 1000 Beedies      |
| (b) for Beedies more than 2 inches long but less than 3 inches | - | Rs. 182.00 per 1000 Beedies, and |
| (c) for Beedies not less than 3 inches long                    | - | Rs. 200.00 per 1000 Beedies      |

The minimum rates of wages for piece work for Beedi Rolling (inclusive of filling wrappers with "Beedi Tobacco", Beedi Rolling and tying rolled Beedies but exclusive of the preparation of wrappers for rolling and cutting wrapping leaves) shall be:-

|--|---|----------------------------------|
| (a) for Beedies not more than 2 inches long                    | - | Rs. 122.00 per 1000 Beedies      |
| (b) for Beedies more than 2 inches long but less than 3 inches | - | Rs. 136.00 per 1000 Beedies, and |
| (c) for Beedies not less than 3 inches long                    | - | Rs. 150.00 per 1000 Beedies      |

The minimum rates of wages for piece work for cutting, wrapping leaves (inclusive of the preparation of wrappers for rolling) shall be:-

- |  |   |                                 |
|--|---|---------------------------------|
| (a) for Beedies not more than 2 inches long                    | - | Rs. 80.50 per 1000 Beedies      |
| (b) for Beedies more than 2 inches long but less than 3 inches | - | Rs. 87.50 per 1000 Beedies, and |
| (c) for Beedies not less than 3 inches long                    | - | Rs. 94.00 per 1000 Beedies      |

The minimum rates of wages for piece work for fixing ring labels round rolled Beedies shall be Rs. 20.00 per 1000 Beedies.
