### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Sixty-eight (68) allotments of lands numbered 1 to 68 in total extent of about 0.4356 Hectare depicted in Surveyor General's Advance Tracing No. Gam./Kel./96/79 and dated 20.11.1998 situated in Gonawala village in Biyagama Divisional Secretary's Division in Gampaha District in Western Province and bounded and named as follows:
