THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-Section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Five (5) allotments of land in total extent of about 0.0147 Hectare, depicted in Advance Tracing No. Maha / UDP/2006/192 of 07.08.2006 prepared by the Surveyor-General, situated in the village of Unambuwa Mount Temple in the Divisional Secretary's Division of Udapalatha in Kandy District and bounded as follows:

01. Lot 'A' – Extent: 0.0083 Hectare

North and East: Mount temple colony claimed by Puwakarambedara Agnas; South: Mount Temple Colony claimed by Puwakarambedara Agnas and Lots C, D and E; West: Lot B and Mount Temple Colony claimed by Puwakarambedara Seelawathi.

North: Lots B, A; East: Lots C, D; South: Road, Mount temple colony claimed by Puwakarambedara Seelawathi; West: Mount temple colony claimed by Puwakarambedara Seelawathi.

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

The land called Polatagama Waththa about 7.098 Hectares in extent depicted as Lot Nos. 1, 2, 3, 4, 5 and 6 in Advance Tracing

No. KE/YTY/2007/07 and 15.10.2007, prepared by the Surveyor-General, situated in the village of Welihelathenna in Lower Bulathgama Minor Division in Yatiyantota Divisional Secretary's Division in Kegalle District in Sabaragamuwa Province and bounded as follows:

Lot No. 01 – Polatagama Estate – Extent: about 1.046 Hectares

North: Estate Road and Polatagama Estate; East: Polatagama Estate; South: Stream; West: Stream and Estate Road.
