THE OFFICIAL SECRETS ACT (CHAPTER 39)

Order under Sub-section (1) of Section 2

BY virtue of the powers vested in me by Sub-section (1) of Section 2 of the Official Secrets Act, (Chapter 39) read with Paragraph (2) of Article 44 of the Constitution, I, Mahinda Rajapaksa, President, do by this Order declare that:-

- (a) the area of land comprising the Hantana Mountain Range specified in the Schedule to this Order shall be a Prohibited Place for the purposes of the aforesaid Act;
- (b) the Secretary to the Ministry of the Minister in charge of the subject of Defence shall be the Competent Authority for the purposes of this Act;
- (c) no person, other than a person to whom the Competent Authority has in terms of Section 15 issued a permit, may enter or remain within the aforesaid Hantana Mountain Range Prohibited Place; and
- (d) any person authorised to enter or remain within the Hantana Mountain Range Prohibited Place shall within such place engage only in such purpose and subject such conditions as shall be specified in the permit.

SCHEDULE

The area of land comprising the Hantana Mountain Range Prohibited Place shall be as depicted in Survey Plan No. Maha/MHN/2006/683, and shall be bounded as follows:-

<i>North</i>	:	by estate roads;
<i>East</i>	:	by the Kandy-Galaha main road;
<i>South</i>	:	by the Kandy-Galaha main road and the Hantana Watte Forest;
<i>West</i>	:	by the Hantana Watte Forest.

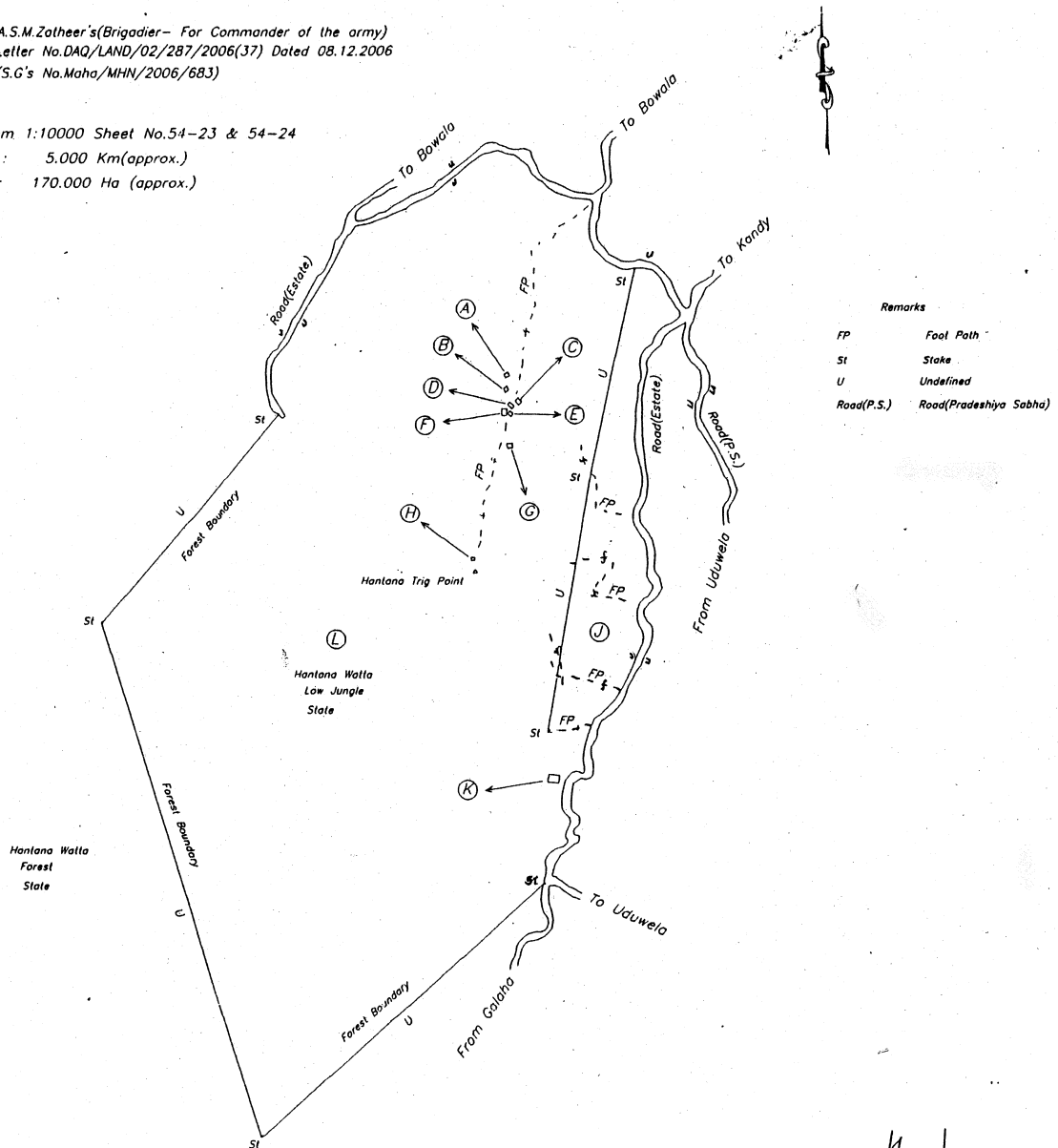
TRACING SHOWING PROPOSED HIGH SECURITY ZONE IN HANTANA AREA
