FILLING OF A VACANCY IN THE OFFICE OF CHAIRMAN OF THE NAVEETHANVELI PRADESHIYA SABHA UNDER SECTION 65A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of the Chairman in Naveethanveli Pradeshiya Sabha has fallen vacant by reason of resignation ;
