THE URBAN DEVELOPMENT PROJECTS (SPECIAL PROVISIONS) ACT, No. 2 OF 1980

Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Urban Development Projects (Special Provisions) Act, No. 2 of 1980, I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka, upon the recommendation of the Minister-in-charge of the subject of Urban Development, being of the opinion that the allotments of land specified in the following Schedule are urgently required for the establishment of Free Trade Area for Wholesale Building Material Center at Godagama do by this order, declare that the said land is required for aforesaid purpose.
