NOTIFICATION

It is notified that the Rs. 2.00 adjustment of wages based on one index point change in the 1952 based Cost of Living Index, is equivalent to an adjustment of Rs. 67.00 per index point change in Cost of Living Index, based on 2002, Cost of Living Index Number for the month of November 2008 is 205.2.
