**FILLING OF THE VACANCY IN THE OFFICE OF VICE CHAIRMAN OF THE THIRUKKOVIL PRADESHIYA
SABHA UNDER SECTION 65A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE
(CHAPTER 262)**

WHEREAS the office of the Vice Chairman in Thirukkivil Pradeshiya Sabha has fallen vacant by reason of Vice Chairman being appointed as the Chairman.

And whereas the Secretary of the Ilankai Tamil Arasu Kadchi, the recognized political party to which Sangarapillai Sabapathi, the Vice Chairman belonged, was required by me under Section 65A(1) of the aforesaid Ordinance, to decide upon the member of that Thirukkivil Pradeshiya Sabha who belongs to such party who shall be declared elected as the Vice Chairman within a period of thirty (30) days;

And whereas the Secretary of the aforesaid recognized political party has failed to communicate his decision within the period specified;

Now therefore, I, Tennekoon Mudiyanse Laxmendra Damayanthkumara Tennekoon, Returning Officer of Thirukkivil Pradeshiya Sabha, acting in terms of Section 65A(1) of the Local Authorities Elections Ordinance (Chapter 262) do hereby declare Mr. Krishnapillai Sivanandaraja who had secured the next highest number of preferences at the election held on 30th March, 2006 to Thirukkivil Pradeshiya Sabha elected as the Vice Chairman of the Thirukkivil Pradeshiya Sabha in respect of which such vacancy occurred.
