FOREST ORDINANCE

THE order Section 3 “A” of the Forest Ordinance (Chapter 451) as amended by Act, No. 13 of 1966, Act, No. 56 of 1979, Act, No. 13 of 1982, Act, No. 84 of 1988 and Act, No. 23 of 1995.

Order

By virtue of powers vested in me by Section 3“A” of the Forest Ordinance (Chapter 451) as amended by Act, No. 13 of 1966, Act, No. 56 of 1979, Act, No. 13 of 1982, Act, No. 84 of 1988 and Act, No. 23 of 1995, I, Patali Champika Ranawaka, Minister of Environment and Natural Resources do by this order declared the Kandapola – Seethaeliya reserved forest bounded by the limits set forth in the schedule which was declared as a reserved forest by *Gazette* No. 5140 of 20th day of May, 1892 as Kandapola –Seethaeliya conservation forest from 25th day of July, 2008.

SCHEDULE

The land known Kandapola–Seethaeliya forest, lying to the north of the Nuwaraeliya - Badulla road and bounded as follows :-

Northern Boundary : At this point its northern boundary passes round title plans 99, 889 ; 99,890 ; 99,891 ; 99,892 and 99,893 so as to exclude these and runs until it meets the southern boundary of title plan 100,039 thence along the boundary and long the southern boundaries of title plans 105,047 ; 105,045 ; 105,044 ; 105,042 ; 105,041 ; 105,040 and 57,829 until Kadawata trigonometrical station is again reached.

Eastern Boundary : Starting from Kadawata trigonometrical station on the north-east, its eastern boundary runs along, and is coterminous with, the province boundary as far as the Badulla high road, excluding title plan 57,843.

Southern and

Western boundaries : From thence its southern boundary runs along the north side of the high road excluding title plans 50,177 ; 73,491 and 134,723 as far as title plan 78,049 thence passing along the south-east and north-east boundary of that title plan it continues along the north-east side of title plans 73,490 ; 73,489 and 48,971 until it strikes the Nuwaraeliya Local Board Limits. From this point the forest is coterminous with the Local Board limits as far as the East side of the title plan 90,638 and South side of title plans 97,681 and 100,036 and up the Kandapola Oya to the Uda Pussellawa road excluding title plan 90,260. From the junction of the stream and road the forest marches with the road as far as Kandapola Bazaar.
