## PART I : SECTION (I) — GENERAL

### Government Notifications

#### RELIGIOUS ZONE — HATTON TOWN

THE Urban Development Authority has declared the Hatton-Dickoya Urban Council Area as an Urban Development Area under Section 03 of the UDA Law No. 41 of 1978 by an *Extraordinary Gazette* No. 100/4 in 1980.

Further to this declaration as the Minister of Urban Development and Sacred Area Development, I notice the general public that the area encompassing all Religious Places located within the Hatton Town as a Religious Zone in Order to maintain , manage and to achieve the following :

- (i) Relocation of incompatible land uses and the conservation of suitable land uses and buildings.
- (ii) Facilitation of parking and pedestrian movements.
- (iii) Reservation of architectural, landscaping, institutions and improvements of the environment.
- (iv) Controlling of hoardings, name boards and advertisements.
- (v) Any other activities to improve the above.

#### The metes and bounds of the Religious Zone :

*North* : From a point 400m distance South West wards drawn perpendicular to the center line of Avissawella - Nuwara Eliya road (A7 Road) at culvert No. 73/3 falls on the Western boundary of Hatton Dickoya Urban Council limit, a line drawn North East wards along the said perpendicular line until it meets the center line of Avissawella - Nuwara Eliya road (A 7) at culvert No. 73/3 and extended to meet the Eastern boundary of Hatton Dickoya Urban Council limits : Thence, a line drawn South East wards, until it meets a point at a distance of 550m along the Eastern boundary of Hatton Dickoya Urban Councils limits ;

*East* : From the last mentioned point a line drawn South East wards along the Eastern boundary of Hatton Dickoya Urban Council limits, until it meets the center line of a Dickoya stream at culvert No. 3/3 on Hatton, Maskeliya road ;

*South* : From the last mentioned point a line drawn North West wards along the center line of the above mentioned “Dickoya” stream until it meets the Western boundary of Hatton Dickoya Urban Council limits ;

*West* : From the last mentioned point a line drawn North East wards, North West wards, West wards along the Western boundary of Hatton Dickoya Urban Council limits until it meets the starting points.
