5. Nomination papers in the prescribed Form can be obtained from the Returning Officer free of charge before the expiry of the nomination period.

6. Approved symbols for recognized political parties and approved symbols and distinguishing numbers for independent groups will be allotted by the Returning Officers at each of the District Secretariat (Kachcheri), immediately after 12.00 noon on 04th July, 2008.
