THE PUBLIC SECURITY ORDINANCE (CHAPTER 40)

REGULATIONS made by the President under Section 5 of the Public Security Ordinance (Chapter 40).

Regulations

The Emergency (Prevention and Prohibition of Terrorism and Specified Terrorist Activities) Regulations, No. 07 of 2006 published in *Gazette Extraordinary* No. 1474/5 of December 06, 2006 and deemed to be in force by virtue of Section 2A of the Public Security Ordinance (Chapter 40), as last amended by Regulation published in *Gazette Extraordinary* No. 1511/9 of August 21, 2007 are hereby further amended as follows :-

- (1) in regulation 1 thereof, by the Substitution for the words “(Prevention and Prohibition of Terrorism and Specified Terrorist Activities)” of the words, “(Prevention and Prohibition of Terrorism and Specified Terrorist Activities)” ;
- (2) by the repeal of regulation 5 thereof, and Substitution therefore of the following :-

“5. Being mindful, of the need efficaciously give effect to obligations cast on the Democratic Socialist Republic of Sri Lanka by international Conventions and other legally binding international legal instruments relating to the prevention and suppression of terrorism to which Sri Lanka is a Party, including in particular the United Nations Security Council Resolution No. 1373 (2001) adopted on September 28, 2001 under Chapter VII of the United Nations Charter is became obligatory for the Government of Sri Lanka to take meaningful measures to prevent and suppress terrorism.” ;

(3) by the repeal of regulation 6 thereof, and substitution therefore of the following :-

“6. No person or groups of persons either incorporated or unincorporated including an organization, shall either individually or as a group or groups or through other persons engage in :-

(a) terrorism ; or

(b) any specified terrorist activity ; or

(c) any other activity in furtherance of any act of terrorism or specified terrorist activity committed by any person, group or groups of persons.” ;

(4) in regulation 7 thereof, by the repeal of Paragraph (d) and Substitution therefor of the following :-

“(d) harbour, conceal, assist a member, cadre or any other associate of ; ” ;

(5) in regulation 8 thereof, by the Substitution for all the words from “No person shall engage in” to “regulations 6 and 7 of these regulations ; ”, of the following :-

“No person shall engage in any transaction in any manner whatsoever, including contributing, providing, donating, selling, buying, hiring, leasing, receiving, making available, funding, distributing or lending materially or otherwise, to any person, group or groups of persons either incorporated or unincorporated, or with a member, cadre or associate of such a person, group or groups of persons, which acts in contravention of regulations 6 and 7 of these regulations :”.
