Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that act.

An allotment of land called Waithalawa Watta, shown as Lot 'A' in extent of about 9.7123 Hectares, depicted in the Advance Tracing No. Maha/UDD/2001/335, dated 07th September, 2003, prepared by the Surveyor-General, situated in the village of Namadagala in Minor Division of Udasiya Pattu in Divisional Secretary's Division of Medadumbara in Kandy District in the Central Province and bounded as follows:

01. Lot 'A' – Waithalawa Watta – Extent: 9.7123 Hectares

North: Waithalawa Watta claimed by State Plantations Corporation; East: Road and Waithalawa Watta claimed by State Plantations Corporation; South: Waithalawa Watta claimed by State Plantations Corporation and Road; West: Road.

Three (03) allotments of land called Waithalawa Watta, shown as Lots 'A', 'B' and 'C' in extent of about 16.428 Hectares, depicted in the Advance Tracing No. Maha/UDD/2006/458, dated 10th July, 2007, prepared by the Surveyor-General, situated in the village of Namadagala in Minor Division of Udasiya Pattu in Divisional Secretary's Division of Medadumbara in Kandy District in the Central Province and bounded as follows:

01. Lot 'A' – Waithalawa Watta – Extent: 5.692 Hectares

North: Canal and Road; East: Road; South: Waithalawa Watta claimed by State Plantations Corporation; West: Canal and Road.

02. Lot 'B' – Waithalawa Watta – Extent: 8.162 Hectares

North: Waithalawa and Road; East: Road, Waithalawa Watta claimed by State Plantations Corporation; South: Road, Waithalawa Watta claimed by State Plantations Corporation, Waithalawa and Road; West: Road and Waithalawa.

03. Lot 'C' – Waithalawa Watta – Extent: 2.574 Hectares

North: Waithalawa Watta claimed by State Plantations Corporation; East: Waithalawa Watta claimed by State Plantations Corporation and Road; South: Waithalawa Watta claimed by State Plantations Corporation and Irrigation Canal; West: Irrigation Canal and Waithalawa Watta claimed by State Plantations Corporation.
