**THE FOREST ORDINANCE**

REGULATIONS made by the Minister of Environment and Natural Resources under Sub-section (1) of Section 24 of the Forest Ordinance (Chapter 451).

**Regulations**

1. These Regulations may be cited as the Forest Regulations No. 01 of 2008, and shall come into force on 01<sup>st</sup> June, 2008.

2. No person shall within, into or out of any area specified in Column I of the First Schedule to this regulation, transport otherwise than under the authority of a permit issued in that behalf in terms of the Forest Ordinance (Chapter 451) by an officer specified in the corresponding entry in Column III of that Schedule, any timber belonging to any one of the species specified in Column II of such Schedule.

3. The transportation within the area specified in Column I of the Second Schedule any species of timber specified in the corresponding entry in Column II of that Schedule shall be exempted from the provisions of paragraph (b) of Sub-section (1) of Section 24 of the Forest Ordinance.

4. The Forest Regulations No. 1 of 2005 published in the *Gazette Extraordinary* No. 1380/30 of February 18, 2005 and No. 1388/7 of April 11, 2005 and No. 1447/19 of May 31, 2006 are hereby rescinded.
