Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Thirteen (13) allotments of land in total extent of about 1.4924 Hectares, depicted as Lots 1 to 13 in Advance Tracing No. MR/DVN/2007/471 and dated 22nd January, 2008, prepared by the Surveyor-General, situated in the village of Naotunna, Wellabadapattu West Minor Division of Divisional Secretariat Devinuwara in Matara District in Southern Province and bounded as follows:

- 01. Lot 'A' – Viyanaruwa – Extent: 0.0433 Hectare**
North: Lot B and road (RDA); East: Lot B; South: Lots B and D; West: Road (PS) and road (RDA).

08. Lot 'H' – Thabiliyanakumbura – Extent: 0.0262 Hectare
North: PP. MR. 1568; East: Canal; South: Canal; West: Lot J.

09. Lot 'J' – Thabiliyanakumbura – Extent: 0.0245 Hectare
North: PP. MR. 1568; East: Lot H; South: Canal; West: Lot K.
