#### FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE CHILAW PRADESHIYA SABHA UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of a member in Chilaw Pradeshiya Sabha has fallen vacant by reason of not attending meetings of the Council for a period of three months without permission ;
