#### FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE ERAVUR TOWN PRADESHIYA SABHA UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of a member in Eravur Town Pradeshiya Sabha has fallen vacant by reason of resignation ;

And whereas the Secretary of the United People's Freedom Alliance, the recognized political party to which Mohamed Sarif Zubair, the member belonged, was required by me under Section 65A(2) of the aforesaid Ordinance, to nominate a person eligible under the Ordinance for Election as a member of that Eravur Town Pradeshiya Sabha who belongs to such party who shall be declared elected as a member within a period of thirty (30) days;

And whereas the Secretary of the aforesaid recognized political party has failed to make a nomination within the period specified ;

Now therefore, I, Thuraisingam Krishnananthalingam, Returning Officer of the Eravur Town Pradeshiya Sabha, acting in terms of Section 65A(2) of the Local Authorities Elections Ordinance (Chapter 262) do hereby declare Mr. Meeralebbe Repupasam who had secured the highest number of preference next to the last of the member declared elected at the elections held on 20th May, 2006 to Eravur Town Pradeshiya Sabha elected as a member of the Eravur Town Pradeshiya Sabha in respect of which such vacancy occurred.

**FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE PANDUWASNUWARA PRADESHIYA SABHA UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE  
(CHAPTER 262)**

WHEREAS the office of a member in Panduwasnuwara Pradeshiya Sabha has fallen vacant by reason of not attending meetings of the Council for a period of three months without permission ;
