#### Declaration under Section 5

#### Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Description of the land to be acquired:

Three (03) allotments of land in total extent of about 0.5674 Hectare, depicted as Lots 'A', 'B' and 'C' in Advance Tracing No. MAHA/HRS/2007/436 and dated 18th February, 2008, prepared by the Surveyor-General, situated in the village of Senarathgama North within the Kulugammana Siyapattuwa Minor Division in Divisional Secretary's Division of Harispattuwa in Kandy District and bounded as follows:
