SRI LANKA EXPORT DEVELOPMENT ACT, No. 40 OF 1979

Order under Section 14

BY virtue of powers vested in me by Section 14(1) of the Sri Lanka Export Development Act, No. 40 of 1979, I, Mano Wijerathne, Acting Minister of Export Development and International Trade with the concurrence of the Minister of Finance and Planning, do by this Order declare that with effect from 17th September, 2008 a Cess shall be charged, Levied and paid on all goods enumerated in Column III of the Schedule I hereto at rates specified in the corresponding entry in Column IV in the same Schedule hereto, on the aggregate of a sum equivalent to their value for Customs duty purposes at the time of importation and a sum equivalent to ten per centum of such value.
