THE LAND REFORM LAW No. 1 OF 1972 OF THE NATIONAL STATE ASSEMBLY

Order made under Section 22(1)

I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka and Minister-in-charge of the subject of Land Reform in pursuance of powers vested in me by Land Reform Law, No. 1 of 1972 of the National State Assembly as amended by Land Reform (Special Provisions) Law, No. 39 of 1981 read with Article 44(2) of the Constitution of the Democratic Socialist Republic of Sri Lanka, do by this Order alienate to the persons stated in entry corresponding to Column I of the Schedule here to the agricultural lands stated in Column II of the Schedule hereto who had been owners of the said lands and who had been below eighteen years of age by the date the land ceiling in respect of agricultural lands was imposed and such lands being lands not alienated to any person under Section 22 of the said Law of the National State Assembly and against which no compensation had been paid to any person in terms of Section 28 of same Law.
