**ORDER MADE UNDER SECTION 22(1) F OF LAND REFORM LAW No. 1 OF 1972 OF  
THE NATIONAL STATE ASSEMBLY**

I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka in pursuance of powers vested in me by Land Reform Law No. 1 of 1972 as amended by Land Reform (Special Provisions) Law No. 39 of 1981 read with Article 44(2) of the Constitution of the Democratic Socialist Republic of Sri Lanka, do by this Order alienate to the persons referred to in entry corresponding to column I of the Schedule here to the agricultural lands referred to in column II of the Schedule hereto which being lands not alienated to anybody under Section 22 of the said Law of the National State Assembly and for which no compensation whatever had been paid to anybody under Section 28 of the said Law of the National State Assembly and also the said persons referred to in the said entry being persons who had been the owners of the said lands below the age of 18 years on the date the Ceiling on ownership of Agricultural Lands referred to in Column II of the Schedule hereto was imposed.
