TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)

Order under Section 6(2)(b) and Section 21(2)(b)

BY virtue of the powers vested in me by Section 6(2)(b) and Section 21(2)(b) of the Town and Country Planning Ordinance (Chapter 269), I, Dinesh Chandra Rupasinghe Gunawardana, Minister of Urban Development and Sacred Area Development, do by this order :-

- (a) declare that the area of land specified in the Schedule hereto shall be an Urban Development Area for the purpose of the aforesaid Ordinance and shall be called “Bambalapitiya Sri Vajirarama Sacred Area”; and
- (b) direct that an out line scheme shall be prepared for the area declared to be the Bambalapitiya Sri Vajirarama Sacred Area.

SCHEDULE

THE AREA OF LAND COMPRISING THE BAMBALAPITIYA SRI VAJIRARAMA SACRED AREA

All that area of land containing in extent 0.5849 Hectares and depicted in the Survey General's Tracing No. CO/THI/2009/295, dated July 29, 2009, situated in the Grama Niladhari Divisions of Bambalapitiya and Milagiriya in the Divisional Secretary's Division of Thimbirigasyaya, in the Administrative District of Colombo in the Western Province and bounded as follows :-

- North* : by Vajira Road, Lot No. 1 on the Plan and premises bearing assessment No's. 14/9 and 14/9A Vajira road ;
- East* : by the road, premises bearing assessment No's 14/9, 14/9A, 14 and 14C Vajira Road and lot No. 2 on the Plan ;
- South* : by the road, Lot No. 2 on the Plan, premises bearing assessment No's 23, 21, 19 and 15 on Vishaka Road and the road ; and
- West* : by Lot No. 2 and 3 on the Plan, premises bearing assessment No's 23, 21, 19 and 15 on Vishaka Road, premises bearing assessment No.'s 12/1 and 12/4 Vajira road and the road.
