I, Jeewan Kumaranatunga, Minister of Lands and Land Development hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act that the land described below is needed for laying Mahakanda Distribution Pipeline of Kandy South Water Supply Projects and will be acquired under the provisions of that Act.
