TRUSTS ORDINANCE (CHAPTER 87)

Order under Section 114

WHEREAS the Trustees of the “Jaffna College Alumni Association, Colombo Branch Trust ” namely —

1. Mr. Ampalam Kandasamy (President of the Jaffna College Alumni Association, Colombo Branch, *ex-officio* member),
2. Mr. Ariyaratnam Chandrarajah, (Secretary of the Jaffna College Alumni Association, Colombo Branch, *ex-officio* member),
3. Mr. Manickan Thavayogarajah,
4. Mr. Sivapragasam Panchcharavel,
5. Mr. Manoharan Devasagayam,
6. Mr. Subramaniam Thirugnansambanthat, and
7. Mr. Noel A. Vimalendran (Principal, Jaffna College, *ex-officio* member).

have applied to the Minister of Justice and Law Reforms for their incorporation under Section 114 of the Trusts Ordinance (Chapter 87).

Now therefore, by virtue of the powers vested in me by the aforesaid Ordinance, I, Milinda Moragoda, Minister of Justice and Law Reforms, do by this Order, authorize the incorporation of the said Trustees and direct and declare that —

- (a) the Trustees of the said Trust named above and their successors for the time being duly appointed under the rules of the said Corporation and the Declaration of Trust bearing No. 1827 of June 13, 2009 attested by Kandiah Neelakandan, Notary public of Colombo, and shall be a body corporate with perpetual succession and a common seal under the name and style of the “Jaffna College Alumni Association, Colombo Branch Trust ” ;
- (b) the said Trustees may under the said name and style purchase, receive, hold take on loan or otherwise acquire, sell, exchange, mortgage, pledge, lease or otherwise dispose of movable or immovable property of any description on behalf of the said Trust ; and

- (c) the Trustees shall by the said name and style be able and competent in law to sue and be sued, to answer and to be answered to defend and to be defended, in any Court in Sri Lanka or elsewhere in all causes and actions arising in relation to the said Trust.

This Order may be revoked, or from time to time be varied or amended in such manner as appear to me to be necessary.
