#### FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE MAWANELLA PRADESHIYA SABHA UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of a member in Mawanella Pradeshiya Sabha has fallen vacant by reason of being ceased to be a member of the party ;

And whereas the Secretary of the United National Party, the recognized political party to which Muhammadu Ibrahim Muhammadu Yaseen, the member belonged, was required by me under Section 65A(2) of the aforesaid Ordinance, to nominate a person eligible under the Ordinance for Election as a member of that Mawanella Pradeshiya Sabha who belongs to such party who shall be declared elected as a member within a period of thirty (30) days;

And whereas the Secretary of the aforesaid recognized political party has failed to make a nomination within the period specified ;

**FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE BALAPITIYA PRADESHIYA SABHA  
UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE
