FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE TAWALAMA PRADESHIYA SABHA UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of a member in Tawalama Pradeshiya Sabha has fallen vacant by reason of being ceased to be a member of the party ;
