Upon coming into effect the order mentioned in para. 01 above, the Order made under Section 7 and published in the *Gazette Extraordinary*, No. 1488/3 dated 12th March, 2007 of the Democratic Socialist Republic of Sri Lanka and amendments thereto shall cease to apply in respect of any turnover arising from the date of 30th September, 2009.
