Inquiry being held under Section 2 of the Statute of the Powers of Supervision of the Administration of Local Authorities No. 4 of 1991 of the Western Province

I, Pestheruwe Liyanaralalage Reginold Rosmand Cooray Wijewarnasooriya, Chief Minister and the Minister in-charge of Law and Order, Finance and Planning, Education, Employment, Local Government and Local Administration, Transport and Culture and Art Affairs of the Provincial Council of the Western Province, by virtue of the powers vested in me in terms of Section 2(2) of the Statute of the Authority of Supervision of Administration of Local Authorities No. 04 of 1991 of the Provincial Council of Western Province, do hereby appoint you as the one man Tribunal to inquire into and submit a report within a period of three months hereof in respect of any reasons offences referred to in Section 2(1) of the said Statute have been committed by Mr. Athukorala Dammika Sumith (Mr. D. Sumith Athukorala) Member of the Panadura Pradeshiya Sabha by reason of the following allegation.

The said allegation to be probed is as follows :

- (a) “You have committed the offence/offences referred to in the Section/Sections 2(1)(C) and/or 2(1)(D) of the Statute of the Authority of Supervision of Administration of Local Government Bodies No. 04 of 1991 of Provincial Council of Western Province by acting contrary to the Section 219(1) of the Pradeshiya Sabha Act bearing No. 15 of 1987 by executing the contract relating to the project whose value stands at Rs. 348,705.90 which is for completely tarring the damaged places and cracks of the portion from Kiriberiya to Malmawatha at the turn off to Newdawa of the Kiriberiya main road ” of Panadura Pradeshiya Sabha within the period from 25th September, 2007 to 11th January, 2008 or thereabouts while acting as Member of Panadura Pradehiya Sabha during the period from 16th April, 2006 to date having obtained the said contract to the Rural Development Society of Malamulla West which is being conducted at your permanent address of No. 41C, Malamulla West, Malamulla under your chairmanship and having made request to the Panadura Pradehiya Sabha.

Further, I would like to inform you that for the purpose of this inquiry you are vested with the powers belonging to a Commissioner appointed under the Tribunal Act as per the provisions further mentioned in the Section 2(2) of the said Statute of the powers of Supervision of the Administration of Local Authorities No. 04 of 1991 of the Provincial Council of Western Province and that the report inclusive of the findings of the inquirer to be conducted be submitted to me within a period of three months from the date of this appointment.
