I, Dimingu Badathuruge Priyanthi Suranjana Vidyaratne, Director General of Census and Statistics, being the Competent Authority, appointed under Section 20(2) (d) of the Wages Boards Ordinance (Chapter 136), by the Minister by notification published in *Gazette* No. 9,327 of November 3, 1944 No. 9,963 of April 1, 1949, No. 10,541 of June 25, 1953, No. 11,568 of October 27, 1958 and No. 13,179 of June 22, 1962, do hereby declare that the Cost of Living Index Number (based on 2002), for the month of January, 2009, applicable to workers in each of the trades specified in the Schedule hereto is 203.1.

It is notified that the Rs. 2.00 adjustment of wages based on one index point change in the 1952 based Cost of Living Index, is equivalent to an adjustment of Rs. 67.00 per index point change in Cost of Living Index, based on 2002, Cost of Living Index Number for the month of December 2008 is 203.7.
