**NATIONAL WATER SUPPLY AND DRAINAGE BOARD ACT, No. 02 OF 1974 OF THE  
NATIONAL STATE ASSEMBLY**

#### Order Under Section 64(1)

BY virtue of the powers vested in me under Section 64(1) of the National Water Supply & Drainage Board Act, No. 02 of 1974, of the National State Assembly I, Ahamed Lebbe Marikkar Athaulla, the Minister of Water Supply and Drainage, do by this order, embody in the Schedule hereto the provisions of the Voluntary Transfer Scheme approved by me under Section 63(1) of the aforesaid Law, in connection with the Watapotha Water Supply Scheme maintained by the Nivithigala Pradeshiya Sabha.

#### Schedule

Section 61(1) – *Contents of the Voluntary Transfer Scheme :*

- (a) All under mentioned movable and immovable property shall be vested with the National Water Supply & Drainage Board, viz,
- (i) All intakes, collecting reservoirs, water storage and distribution tanks, pumping stations of the Watapotha Water Supply Scheme and all lands, buildings, pipelines, network necessary for the implementation and maintenance of the said Water Supply Scheme and all mechanical and electrical machinery and equipment, fixtures, and all spares, accessories and stores items necessary for the maintenance of such machinery and equipment.
  - (ii) Rights of servitudes over land used for the purpose of laying pipelines, spares, accessories and stores items along with all main water supply, water distribution pipeline network necessary for

the implementation and maintenance of the Water Distribution network of the Watapotha Water Supply Scheme situated within the area of authority of the Nivithigala Pradeshiya Sabha.

- (b) Any contracts entered into, by the Nivithigala Pradeshiya Sabha in connection with the planning, supplies fixtures, constructions, operations and maintenance of the above mentioned rights, obligations and liabilities of the Pradeshiya Sabha shall be transferred to the Board.
- (c) All agreements entered into by with the consumers of water, in connection with the consumption of water and provision of water supply services, all payments to be made in connection with the procurement of such services, shall be transferred to the Board.
- (d) The state shall confer the value of such facilities amounting to Rs. 50,000 (Sri Lanka Rupees Fifty Thousand) as a grant to the Board.
- (e) The Board shall continue to maintain without interruption all agreements entered into, by the Pradeshiya Sabha in connection with the provision of water supply services and shall also fulfill the contractual obligations.

The said transfer shall come into operation with effect from the date of publication of this Notice.
