LAND REFORM LAW No. 1 OF 1972 OF THE NATIONAL STATE ASSEMBLY

Order made under Section 27(a)(1)

I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka in pursuance of powers vested in me by Section 27 (a)(1) of Land Reform Law No. 1 of 1972 of the National State Assembly as amended by Act, No. 39 of 1975, Act, No. 14 of 1981, Act, No. 39 of 1981, Act, No. 14 of 1986 and Act, No. 18 of 1986 read with Article 44(2) of the Constitution of the Democratic Socialist Republic of Sri Lanka, do by this Order alienate to the Road Development Authority established by the road Development Act, No. 73 of 1981 the agricultural lands vested in the Land Reform Commission and referred to in Schedule 01 hereto with effect from the date of this order for the purpose set out in schedule 02 hereto in consideration of the sum of Two Million and two hundred and Fifty Thousand Rupees (2,250,000) paid to the Land Reform Commission by the said Road Development Authority.

The right to possession of the mineral resources of the said land remains further retained with the Land Reform Commission.
