LAND REFORM LAW No. 1 OF 1972

Order under Section (a)(4)

I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka under powers vested in me by Section 27(a)(4) of the Land Reform Law No. 1 of 1972 of the National State Assembly as amended by Land Reform (Special Provisions) Law, No. 39 of 1981 read with Article 44(2) of the Constitution of the Democratic Socialist Republic of Sri Lanka, do hereby revoke in terms of the provisions of the said amended Land Reform Law, the Order made in terms of the provisions and conditions of Section 27(a)(1) of the Land Reform Law No. 1 of 1972, transferring the land referred to in Schedule I hereto, to the Janatha Estate Development Board established under Agricultural Corporations Act, No. 11 of 1972 and published in the *Gazette Extraordinary* No. 1937/2 of 19th August, 1996.
