THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga Minister of Lands and Land Development hereby declare under Sub-section (1) in Section 5 of the Land Acquisition Act, that the Land described below is required for a public purpose and it is to be acquired under the provisions of the said Act.

Land called Pelengahalanda in Extent of about 0.0376 Hectare depicted as Lot 'A' in the Advance Tracing No. CO/KSB/2007/587 dated 8th February 2008 prepared by the Surveyor General and situated in the village Erawwala East Palle Pattuwa Minor Division within Kesbewa Divisional Secretary's area in Colombo District and bounded as follows:
